Grooves on both sides of the slat rail accommodate independently adjustable monitor setups when desks are pushed together back-to-back.

The stylish aluminum DMSWSLATTAA easily installs into the DMSWKITTAA Slat Rail with Posts. In addition, this slat wall system also has options for three VESA-compliant monitor mounts (DMSW1332STAA, DMSW1332MTAA and DMSW1332LTAA), all sold separately.
