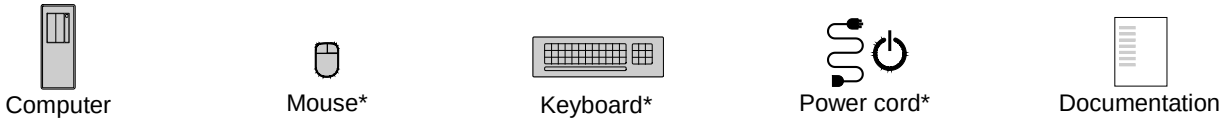

This specification limits the computer's maximum wide band true RMS output voltage to 150 mV. Using headphones that do not comply with EN 50332-2 can be dangerous due to excessive sound pressure levels.

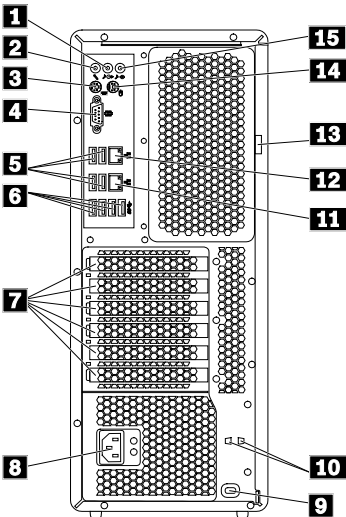

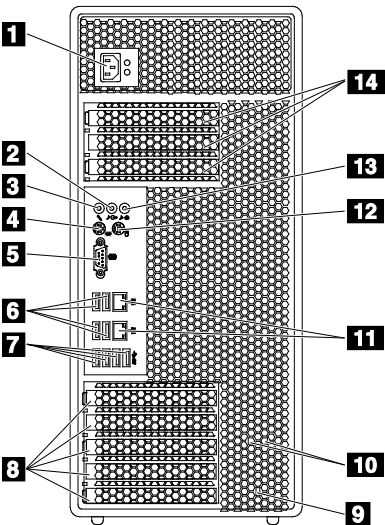

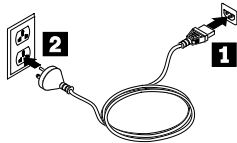

Initial setup instructions

- Connect the keyboard cable and the mouse cable to the appropriate connector respectively (PS/2 or USB).
- If you will be using a wired network connection, connect the Ethernet cable to the Ethernet connector.
- Connect the power cord to the power-cord connector on the computer first and then connect it to a properly-grounded electrical outlet.



Ensure that all power cord connectors are securely and completely plugged into receptacles.

- Press the power button on the front of your computer.

- Follow the on-screen instructions to complete the setup.

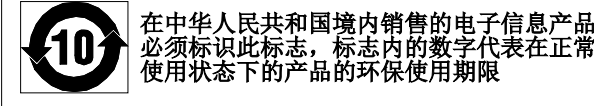
