1 Important safety instructions

Hearing safety

Danger

 To avoid hearing damage, limit the time you use headphones at high volume and set the volume to a safe level. The louder the volume, the shorter the safe listening time is.

Be sure to observe the following guidelines when using your earpieces.

- Listen at reasonable volumes for reasonable periods of time.
- Be careful not to adjust the volume continuously upwards as your hearing adapts.
- Do not turn up the volume so high that you can't hear what's around you.
- You should use caution or temporarily discontinue use in potentially hazardous situations.
- Excessive sound pressure from earphones and headphones can cause hearing loss.
- Using headphones with both ears covered while driving is not recommended and may be illegal in some areas while driving.
- For your safety, avoid distractions from music or phone calls while in traffic or other potentially dangerous environments.

General information

To avoid damage or malfunction:



Caution

- Do not expose headphones to excessive heat.
- · Do not drop your headphones.
- Headphones shall not be exposed to dripping or splashing. (Refer to the IP rating of specific product)
- Do not allow your headphones to be submerged in water.
- Do not charge your headphones when the connector or socket is wet.
- Do not use any cleaning agents containing alcohol, ammonia, benzene, or abrasives.
- Use a clean, damp cloth to clean your headphones - especially the sound conduits and the microphone holes - regularly and avoid buildup of substances such as sweat or earwax.
- If any sweat or water droplets are left in the sound conduits, air holes or microphone holes, the sound level will temporarily drop or cut out entirely. This is not a malfunction. Use a soft, damp cloth to dry the headphones thoroughly. Alternatively, remove the earbud tips, turn the sound conduits downward and gently tap the headphones about five times on a dry cloth or similar to remove any water collected inside.
- Be sure the headphones are completely dry before charging and using. Avoid using disposable alcohol pads or other substances for cleaning.
- The integrated battery shall not be exposed to excessive heat such as sunshine, fire or the like.
- Danger of explosion if battery is incorrectly replaced. Replace only with the same or equivalent type.
- To achieve the specific IP rating, the charging slot cover must be closed.
- Disposal of a battery into fire or a hot oven, or mechanically crushing or cutting a battery, can result in an explosion.
- Leaving a battery in an extremely high temperature surrounding environment can result in an explosion or the leakage of flammable liquid or gas.
- A battery subjected to extremely low air pressure may result in an explosion or the leakage of flammable liquid or gas.
- Replacement of a battery with an incorrect type risks severely damaging the headphones and the battery (for example, in the case of some lithium battery types).
- If the headset is not used for a long time, the rechargeable battery will begin to lose its charge. To avoid this loss, please fully charge the battery at least once every three months.

 To avoid risk of fire, the equipment is supplied only by external power source which output shall comply with PS1 (with output capacity does not exceed 15W).

Operating and storage temperatures and humidity

- Store in a place where the temperature is between -20°C (-4°F) and 50°C (122 °F) with up to 90% relative humidity.
- Operate in a place where the temperature is between 0°C (32°F) and 45°C (113 °F) with up to 90% relative humidity.
- Battery life may be shorter in high or low temperature conditions.



3 Get started

Charge the battery




Note

- Before you use your headphones, charge the battery for two hours for optimum battery capacity and lifetime.
- Use only the original USB charging cable to avoid any damage.
- Finish your call before charging. Connecting the headphones to charge will power them off.
- If the headset is not used for a long time, the rechargeable battery will begin to lose its charge. To avoid this loss, please fully charge the battery at least once every three months.

Plug one end of the USB-C cable into the headphone and the other end into the power source.

LED turns white during charging and turns off when the headphones are fully charged.





Tip

· Normally, a full charge takes 2 hours.

Pair the headphones with your Bluetooth device for the first time

- 1 Make sure that the headphones are fully charged and powered off.
- Press and hold the power button for 2 seconds, the headphones will be in pairing mode and ready to connect.
 - → The LED on headphones flashes white and blue alternately.
 - → The headphones are now in pairing mode and are ready to pair with a Bluetooth device (e.g. a mobile phone).
- 3 Turn on the Bluetooth function of your Bluetooth device.
- 4 Pair the headphones with your Bluetooth device, refer to the user manual of your Bluetooth device.



Note

 After powering on, if the headphones can not find any previously connected Bluetooth device, please put them into pairing mode (press the MFB button for 5 seconds).


The following example shows you how to pair the headphones with your Bluetooth device.

- Turn on the Bluetooth function of your Bluetooth device, select Philips TAK4200.
- 2 Enter the headphones' password "0000" (4 zeros) if prompted. For those devices featuring Bluetooth 3.0 or higher, there is no need to enter a password.



Pair the headphones with another Bluetooth device

If you want to pair another Bluetooth device with the headphones, turn on the headphone, press the MFB button for 5 seconds then discover the second device as per normal pairing.





• The headphones store 4 devices in the memory. If you try to pair more than 4 devices, the earliest paired device is replaced by the new one.

4 Use your headphones

Connect the headphones to your Bluetooth device

- 1 Turn on your mobile phone/ Bluetooth device.
- 2 Press and hold the power button to turn the headphones on.
 - → The blue LED is on for 1 second
 - → The headphones are reconnected to the last connected mobile phone/ Bluetooth device automatically. If the last one is not available, the headphones will be in pairing mode



Tip

 If you turn on the mobile phone/Bluetooth device or activate the Bluetooth feature after turning on the headphones, you have to reconnect the headphones and mobile phone/ Bluetooth device manually.



Note

 If the headphones fail to connect to any Bluetooth device within range of 5 minutes, it will switch off automatically to save the battery life

Note

- You can switch light effect in Philips
 Headphones App. There are 8 dazzling light
 effects you can select.
- 2. You need to long press the **play/pause** button within 5 seconds of being triggered to switch the lighting effects, make sure to switch to the next effect within 5 seconds, after 5 seconds you need to start over from the trigger.



Playtime limit setting

Click "**Settings**" on the bottom menu of the App, and click "**Play Time Limit**" to set the playtime to 30min or 1 hour or 2 hours.




- A voice prompt indicate 'Playtime limit' will be heard and the music will be paused when the playtime limit is reached. The headphones will turn off at the same time.
- It need to wait for 5mins to turn on the headphones again if you want to continue playing from the connected device. There will be a voice prompt indicate 'Playtime limit' if the waiting time is NOT as long as 5mins.

Volume limit setting

On the "**Settings**" menu of the App, the default setting of "**Travel Mode**" will be OFF, the maximum volume is limit to 75dB. When "**Travel Mode**" is ON, the maximum volume will limit to 85dB.



6 Reset the headphones

If you encounter any pairing or connection issue, you can follow the procedure to reset your headphones to factory default settings.

- On your Bluetooth device, go to the Bluetooth menu and remove Philips TAK4200 from the device list.
- 2 Turn off the Bluetooth function of your Bluetooth device.
- 3 Turn on your headphones.
- 4 Press and hold Volume and Volume + for 4 seconds at the same time.
- 5 Follow steps in "Use your headphonesconnect the headphones to your Bluetooth device."
- 6 Pair the headphones with your Bluetooth device, select Philips TAK4200.



10 Frequently asked questions

My Bluetooth headphones do not turn on. The battery level is low. Charge the headphones.

I cannot pair my Bluetooth headphones with my Bluetooth device.

The Bluetooth is disabled. Enable the Bluetooth feature on your Bluetooth device and turn on the Bluetooth device before you turn on the headphones.

How to reset pairing.

Let headphone stay in pairing mode (white and blue light flashes alternately), press and hold "Volume +" and "Volume-" button together more than four seconds until blue LED light on.

I hear but cannot control music on my Bluetooth device (e.g. play/pause/skip forward/backward).

Make sure the Bluetooth audio source supports AVRCP (see 'Technical data' on page 12).

The volume level of the headphones is too low.

Some Bluetooth devices cannot link the volume level with the headphones through volume sync. In this case, you have to adjust the volume on your Bluetooth device independently to achieve an appropriate volume level. For Kids headphones, if you can't hear clearly, it might be due to the volume limit (below 75 dB). Please check the Volume limit setting section to adjust the volume.

The Bluetooth device cannot find the headphones.

- The headphones may be connected to a previously paired device. Turn off the connected device or move it out of range.
- Pairing may have been reset or the headphones have been previously paired with another device. Pair the headphones with the Bluetooth device again as described in the user manual. (see 'Pair the headphones with your mobile phone' on page 7).

My Bluetooth headphones are connected to a Bluetooth stereo enabled mobile phone, but music only plays on the mobile phone speaker.

Refer to the user manual of your mobile phone. Select to listen to music through the headphones.

The audio quality is poor and crackling noise can be heard.

- The Bluetooth device is out of range.
 Reduce the distance between your headphones and Bluetooth device, or remove obstacles between them.
- Charge your headphones.

Clean your headphones regularly.

- Use a clean, damp cloth to clean your headphones - especially the sound conduits and the microphone holes regularly and avoid buildup of substances such as sweat or earwax.
- If any sweat or water droplets are left in the sound conduits, air holes or microphone holes, the sound level will temporarily drop or cut out entirely. This is not a malfunction. Use a soft, damp cloth to dry the headphones thoroughly. Alternatively, for in-ear remove the earbud tips, turn the sound conduits downward and gently tap the headphones about five times on a dry cloth or similar to remove any water collected inside.
- Be sure the headphones are completely dry before charging and using. Avoid using disposable alcohol pads or other substances for cleaning.

If the headset is not used for a long time, the rechargeable battery will begin to lose its charge. To avoid this loss, please fully charge the battery at least once every three months.
