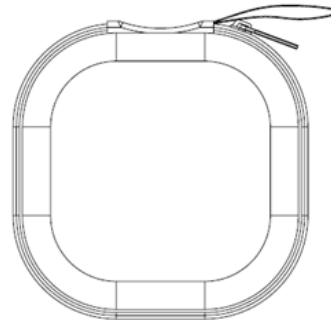





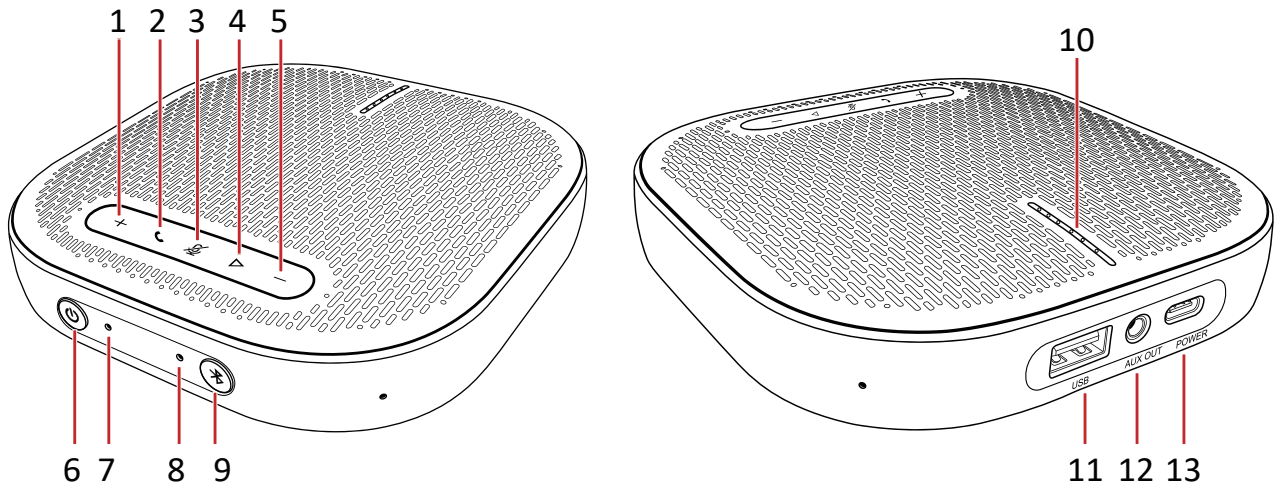

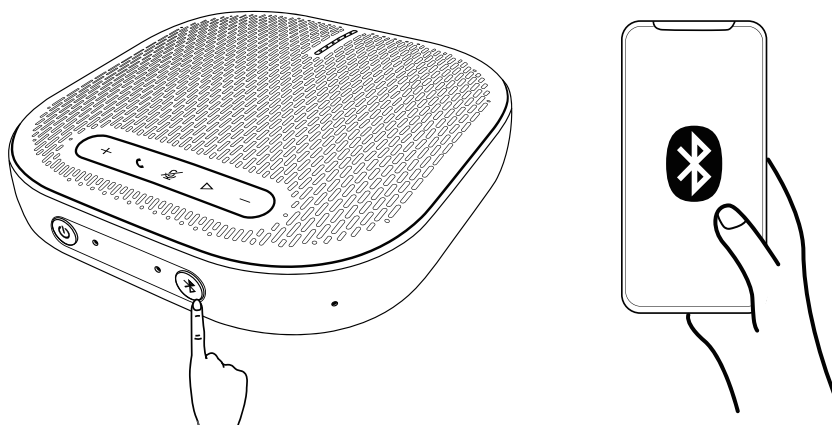
## USB Connection

## Bluetooth Connection

When the speakerphone is powered on for the first time, it will automatically enter Bluetooth pairing mode.



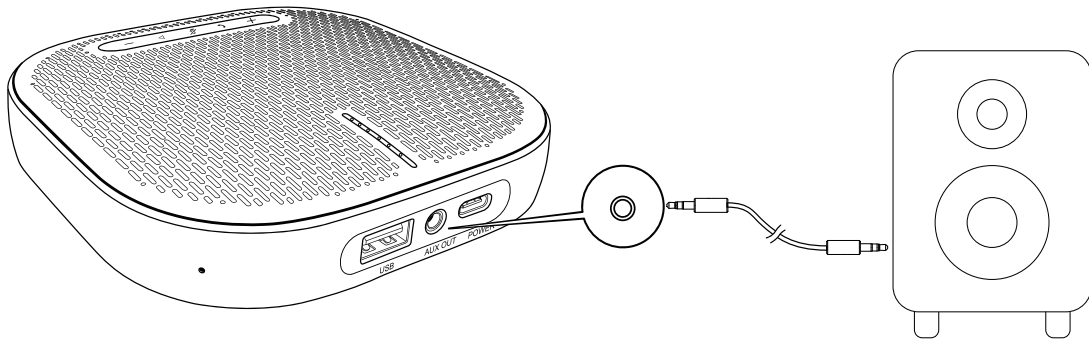
	Press once	Enter pairing mode

### NOTE:

- Every time the speakerphone is powered on, it will automatically connect to previously connected devices (if available).
- To disconnect the Bluetooth connection, press the Bluetooth button again.

## Audio Output

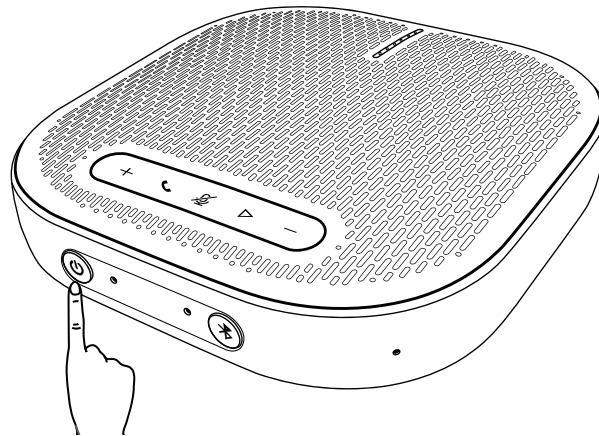
Connect an external speaker to the **AUX** jack of the speakerphone with an AUX cable (not provided). The audio will be played through the external speaker.





# Using the Speakerphone

## Powering On/Off

1. Press and hold the power button for two (2) seconds to turn on the power; the **Status Indicator** will light up from top to bottom then turn off.
2. Press and hold the power button for two (2) seconds to turn off the power; the **Status Indicator** will light up from bottom to top then turn off.






## Power Indicator Status

- After the speakerphone is connected to a computer, it will automatically power on.
- After 30 minutes of no operation or power supply, the speakerphone will automatically power off.

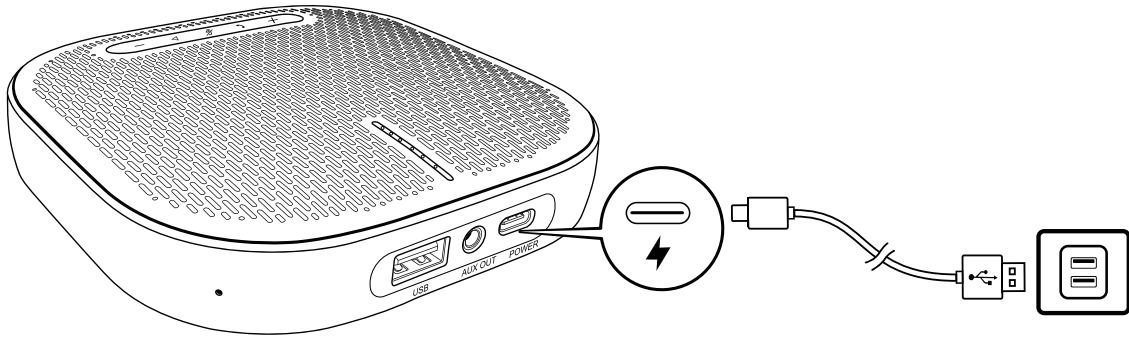

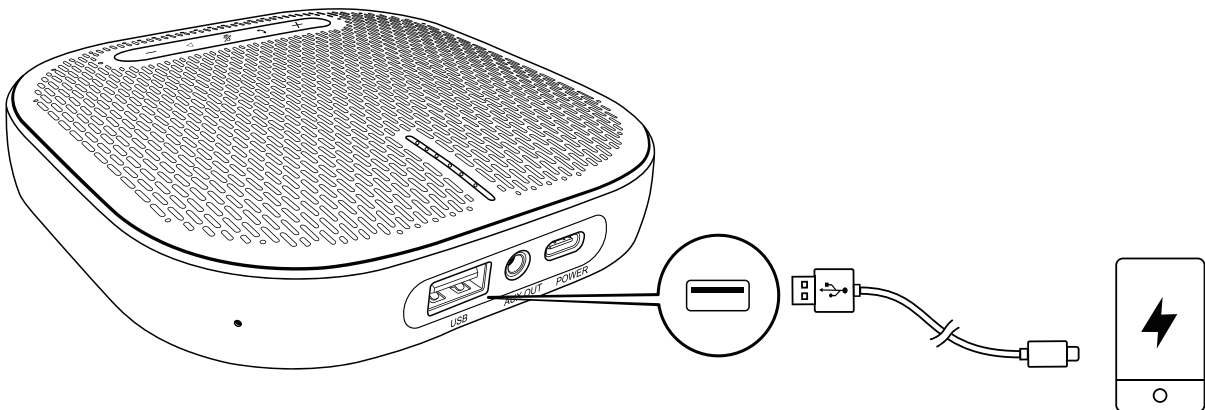

Problem or Issue	Possible Solutions
<b>Why is my conference speakerphone not working?</b>	<p><u>Check the device battery status</u></p> <p>Connect to a computer or USB power source with a USB cable and check the power indicator status:</p> <ul style="list-style-type: none"><li>• White indicator is on: Fully charged</li><li>• Red indicator is flashing: Low battery (needs to be charged immediately)</li></ul> <p><u>Check if the device is connected correctly</u></p> <p>Check your mobile device's Bluetooth menu and delete/forget the VB-AUD-201_XXXX. Re-connect the VB-AUD-201_XXXX to your Bluetooth device.</p>
<b>Why does my conference speakerphone keep cutting out?</b>	<p>Too much distance between the conference speakerphone and the connected device can cause dropped connections.</p> <p>The maximum range for VB-AUD-201 is 20 feet/6 meters. Try moving closer to the device you are connected to. And check the specifications on your connected device to see how close you need to be for maximum connectivity.</p>
