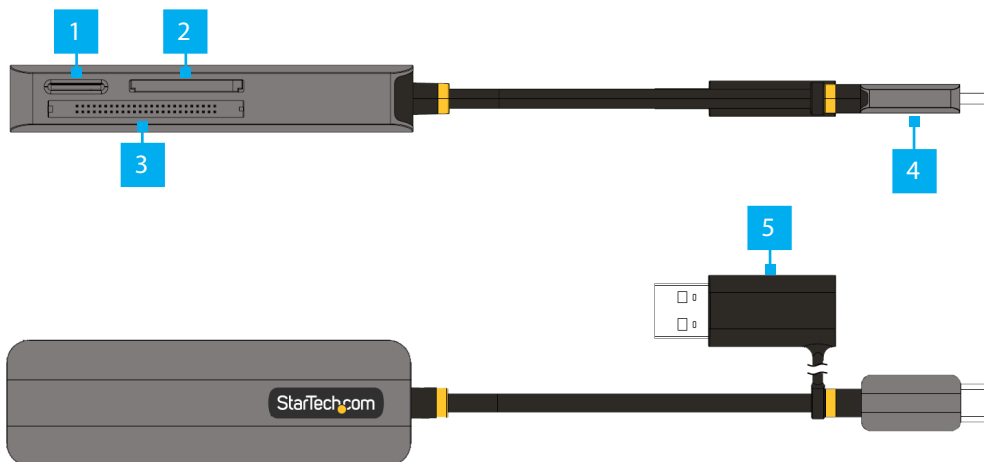

### Installation

**WARNING!** When removing media cards connected to Multi-Media Memory Card Reader, it is required to remove/eject the device from within the operating system. Failure to remove storage devices properly can result in lost data, or permanent damage to the Memory Card or Card Reader.

#### Installing the Multi-Media Memory Card Reader

1. Insert a **Memory Card** into the compatible **Media Card Slot**.  
*Note: The Multi-Media Memory Card Reader supports read/write to all three drives simultaneously.*
2. (Optional) Connect the **Multi-Media Memory Card Reader's USB-A to USB-C Adapter**.
3. Connect the **USB Host Connection** to an available **USB-A or USB-C Port** on the **Host Computer**.
4. The operating system will detect the **Multi-Media Memory Card Reader** and automatically install the correct **Drivers**.

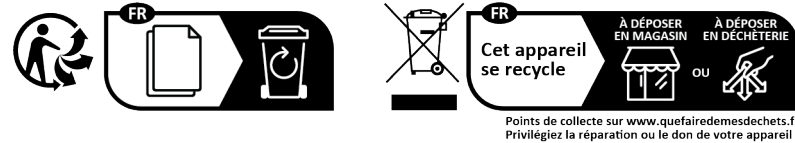
