




Hardware installation




Outdoor cabling

The outdoor cameras are IP66-rated for weather-proof. However, water may still enter the camera if it is not properly installed. Follow the instructions when installing the camera.

 When running cables, slightly bend the cables to a U-shaped curve to make a low point. This is to prevent water from entering the camera along the cables from above.



Seal the cable entry hole with the provided sealant.
