## Installation

- 1. With the computer system powered off, plug the DisplayPort<sup>®</sup> connector from the DP2DVID adapter into the computer's video card.
- 2. Connect the USB connector from the DP2DVID adapter into a USB port on the computer system.
- Connect a DVI-D (digital) cable from the DP2DVID adapter to your display.

**NOTE:** For 2560x1600 operation, a dual link DVI-D cable must be used.

4. Power on the monitor followed by the computer system.No software/driver installation is required.
